The Town of Bass Lake provides many services—some easily visible and others not so much-but all critical. Justin Hall, Town Chair Justin is exactly the kind of person you want as town chair in a diverse rural community like Town of Bass Lake, with

a population (2000 census) of 2,244. With premier lakes, bridges, boat landings, parks, businesses, restaurants and lakeshore properties, there is much demanded of the town board. Hall, 69, spent 39 years in law enforcement, 35 as Chief of Police and 27 of those as City of Hayward Police Chief.

Hall said when the Town of Bass Lake went to a five-man board he decided to run for supervisor. After several years of that he became the town chair. "I still hold that position today and am very proud to serve the people of Bass Lake Township," he said, adding that

he oversees the running of the town along with the other board members. "I chair all the meetings and handle situations as they come up. I coordinate with our town clerk and treasurer

and I work closely with the road supervisor and fire chief."

Hall said in the past several years they have improved the

all involved—the board, department heads, clerk, treasurer and planning committee. He also includes input from the taxpayers as critical in that process. "We have done a lot of improvements in the town while striving to keep the taxes down."

always starts with a quick walk-through of the building, noting air brake pressure on the trucks, and making sure everything looks normal. He does a mental checklist of available firefighters and EMRs for the day and checks wild land fire danger. He is the purchasing agent for the department so he often

deals with vendors and studies the best deals. Fire and safety inspections have to be performed twice yearly on commercial facilities and businesses in Bass Lake

Township and Mullet is in charge of that, as well as having

the truck fire pumps tested and certified. There is fit testing for breathing apparatus, ladders, hoses and instrument calibration. The entire department has been trained in Basic Life Support and certified in AED and CPR, according to Mullet, who said they all carry high visibility vests in their personal vehicles so they can be immediately identified


